#### INTRODUCTION

The SW210P is a compact, powerful, low-profile subwoofer that provides extended low frequency response for specific models in the ED series of high performance point source loudspeakers. Due to its low profile is ideal for corporate and A/V applications and for permanent installations in live music venues, nightclubs and bars, house of worship where subs may have to be fitted under seating or in confined spaces.

The 10" low frequency transducers are equipped with waterproof cones and this feature, together with the moisture resistant cabinet, makes the SW210P suitable for use in light duty outdoor applications. The transducer technology combines 3" sandwich voice coil with fiberglass former, progressive wave Konex spider, cloth surround with DAR technology, high excursion ferrite magnet circuit with demodulating ring, ventilated voice coil and magnet to reduce power compression and to provide always very high performances.

Recessed handles are provided for easy lifting and handing, and the included polyurethane wheels aid transportation, while stacking feet and matching recesses enable secure ground stacks. Four M10 flying points are also provided to allow

suspension in permanent installations. Two Neutrik<sup>®</sup> speakON™ NL4 connectors provide input and link connections.








## **REAR PANEL**

**INPUT** - Power input for the external amplifier. The SW210P does not include a passive crossover for filtering the signal. The connections are the following:

LINK - Power output in parallel with the INPUT socket for connecting the unit to another speaker. The number of SW210P cabinets that can be connected in parallel depends on the amplifier load capacity.
