Achieving the Best Performance

- Use only good quality connection cables (we recommend Kramer high-performance, high-resolution cables) to avoid interference, deterioration in signal quality due to poor matching, and elevated noise levels (often associated with low quality cables).
- Do not secure the cables in tight bundles or roll the slack into tight coils.
- Avoid interference from neighboring electrical appliances that may adversely influence signal quality.
- Position your Kramer KRT-3 away from moisture, excessive sunlight and dust.

- This equipment is to be used only inside a building. It may only be connected to other equipment that is installed inside a building.
- There are no operator serviceable parts inside the unit.

KRT-3 – Introduction

Overview

KRT-3 is a furniture-mounted cable retractor that is easily installed underneath a table-top. You can also install one or more KRT-3 units in conjunction with a Kramer TBUS unit, such as TBUS-1AXL, TBUS-10XL, UTBUS-1XL, UTBUS-2XL and more.

- Convenient and easy to install in any TBUS.
- Intuitive Use Pull and stop or pull and retract.
- Available Cable Types HDMI (High Speed HDMI with Ethernet), VGA, audio (3.5mm), LAN, USB-2.0, USB-3.0, and DisplayPort.
- Maximum Cable Extension Up to 1.8m (6ft).
- Horizontal Mount Easily mounts, independently, under a table or shelf.
- TBUS Compatibility Retractable cable mounts directly into the TBUS insert opening via a cable pass-through opening.
- Installation KRT-3 is sturdy, cost-effective, and easy to install.



The HDMI cable version is used throughout this manual as an example. The same applies to retractors with other cable types.



When retracting the cable, we recommend that you lead the cable so it retracts slowly.

Typical Applications

The KRT-3 is ideal for:

- Boardrooms.
- · Conference rooms.
- Training rooms.
- · Hotel lobbies.
- · Cafes and restaurants.

KRT-3 – Introduction

Defining the KRT-3 Cable Retractor

This section defines the **KRT-3**.




Figure 1: Defining the KRT-3 Cable Retractor

#	Feature	Function
1	Retractor Enclosure	Contains the retractable cable mechanism.
2	Female Connector	Connect to a male connector under a table.
3	Fixed Cable End	Short connector cable.
4	Screw Openings for Mounting Under the Table (3)	Use to attach the KRT-3 directly under a table.
5	Wing-Head Thumb Screw	Use to turn and lock KRT-3 to the TBUS enclosure.
6	TBUS Installation Slot	Insert TBUS body into the slot to attach KRT-3 to a TBUS.
7	Mobile Retractor Cable	Pull to connect to a connector above a table.
8	Retractor-Side Connector	Connect to a male connector.

Installing KRT-3

KRT-3 can be installed in the following ways:

- Attaching KRT-3 to the Underside of a Table, on page 4.
- Attaching KRT-3 to a TBUS, on page 5.

Attaching KRT-3 to the Underside of a Table

You can mount KRT-3 to the underside surface of a table and use it as a standalone device.

To attach KRT-3 under a table:

- Place KRT-3 under the table in the desired location.
 Make sure that the retracting cable faces the edge of the table.
- 2. Pass the 3 4x50 Philips screws through the table screw openings (4) and tighten them to fix the retractor under the table.




Figure 2: Attaching KRT-3 to a Table

Attaching KRT-3 to a TBUS

You can attach one or more **KRT-3** units to the enclosure of any modular Kramer TBUS with pass-through inserts that are installed inside a table. The **KRT-3** units can usually be attached to the front and rear sides of the enclosure, as the left and right sides are fitted with clamps. Alternatively, the clamps can be installed on the front and rear sides to enable attaching **KRT-3** to the left and right sides of the TBUS enclosure.

For TBUS models with a sliding lid (for example, **TBUS-10xI**), you can only use the front side of the enclosure to mount the **KRT-3** units.

Attaching a Single KRT-3 Unit

To Attach the KRT-3 to a TBUS unit:

1. Slide the **KRT-3** onto one of the sides of the TBUS enclosure. Make sure to position the fixed cable (3) downwards and the retractor cable (7) upwards.




Figure 3: Sliding KRT-3 onto the TBUS Enclosure

KRT-3 – Installing KRT-3

2. Use the wing-head thumb screw 5 to fix the KRT-3 firmly in place.





Figure 4: Tightening KRT-3 to the TBUS Enclosure

- 3. Attach the WCP-(KRT) insert in the following way:
 - a. Insert the cable through the bushing opening.
 - b. Insert the cable with bushing through the insert opening.
 - c. Push the bushing into the insert opening.



d. Use the two M3x5 screws to attach the insert to the TBUS opening.

The KRT-3 is now firmly fixed in place.




Figure 5: KRT-3 Attached to TBUS – Under Table

Attaching Several KRT-3 Units

You can attach several KRT-3 units to a Kramer TBUS:




Figure 6: Attaching Several KRT-3 Units to TBUS with Sliding Cover

• For TBUS units with a sliding cover (for example, the Kramer **TBUS-10xI**), attach the **KRT-3** units side-by-side to the front side of the TBUS enclosure (<u>Figure 6</u>):




Figure 7: Attaching Several KRT-3 Units to TBUS with Regular (Non-Retractable) Cover

• For TBUS units with a regular cover (for example, the Kramer **TBUS-1AxI**), attach the **KRT-3** units side-by-side to the front and rear side of the TBUS enclosure (<u>Figure 7</u>).



To maximize the number of KRT-3 units that can be attached to TBUS-1AXL, TBUS-1-KWC or TBUS-1N, use an inner frame that does not include single or dual power sockets or alternatively, install T-2INSERT/T-4INSERT in the single/dual power socket opening.

You can connect the following devices to the KRT-3.




Figure 8: Connecting KRT-3

The following diagram shows the outline dimensions [cm] of a KRT-3 unit attached to a TBUS (for example, the Kramer TBUS-1AxI).




Figure 9: KRT-3 Attached to TBUS – Dimensions

This limited warranty does not cover cartons, equipment enclosures, cables or accessories used in conjunction with this product. Without limiting any other exclusion herein, Kramer Electronics does not warrant that the product covered hereby, including, without limitation, the technology and/or integrated circuit(s) included in the product, will not become obsolete or that such items are or will remain compatible with any other product or technology with which the product may be used.

How Long this Coverage Lasts

The standard limited warranty for Kramer products is seven (7) years from the date of original purchase, with the following exceptions:

- 1. All Kramer VIA hardware products are covered by a standard three (3) year warranty for the VIA hardware and a standard three (3) year warranty for firmware and software updates; all Kramer VIA accessories, adapters, tags, and dongles are covered by a standard one (1) year warranty.
- All Kramer fiber optic cables, adapter-size fiber optic extenders, pluggable optical modules, active cables, cable retractors, all ring mounted adapters. all Kramer speakers and Kramer touch panels are covered by a standard one (1) year warranty.
- 3. All Kramer Cobra products, all Kramer Calibre products, all Kramer Minicom digital signage products, all HighSecLabs products, all streaming, and all wireless products are covered by a standard three (3) year warranty.
- 4. All Sierra Video MultiViewers are covered by a standard five (5) year warranty.
- 5. Sierra switchers & control panels are covered by a standard seven (7) year warranty (excluding power supplies and fans that are covered for three (3) years).
- 6. K-Touch software is covered by a standard one (1) year warranty for software updates.
- 7. All Kramer passive cables are covered by a ten (10) year warranty.

Who is Covered

Only the original purchaser of this product is covered under this limited warranty. This limited warranty is not transferable to subsequent purchasers or owners of this product.

What Kramer Electronics Will Do

Kramer Electronics will, at its sole option, provide one of the following three remedies to whatever extent it shall deem necessary to satisfy a proper claim under this limited warranty:

- 1. Elect to repair or facilitate the repair of any defective parts within a reasonable period of time, free of any charge for the necessary parts and labor to complete the repair and restore this product to its proper operating condition. Kramer Electronics will also pay the shipping costs necessary to return this product once the repair is complete.
- 2. Replace this product with a direct replacement or with a similar product deemed by Kramer Electronics to perform substantially the same function as the original product.
- 3. Issue a refund of the original purchase price less depreciation to be determined based on the age of the product at the time remedy is sought under this limited warranty.

What Kramer Electronics Will Not Do Under This Limited Warranty

Kramer Electronics will not be responsible for any costs related to any setting up this product, any adjustment of user controls or any programming required for a specific installation of this product.

How to Obtain a Remedy Under This Limited Warranty

You may also be directed to an authorized reseller or a person authorized by Kramer Electronics to repair the product. If it is decided that this product should be returned directly to Kramer Electronics, this product should be properly packed, preferably in the original carton, for shipping. Cartons not bearing a return authorization number will be refused.
