KWC-MUSB Receiver for Micro-USB Connector and KWC-LTN Receiver for Lightning Connector

Congratulations on purchasing your Kramer **KWC-MUSB** and **KWC-LTN** wireless charging receivers. You can use the receivers with the Kramer Wireless Charging (KWC) products.



These receivers are used for mobile devices that **DO NOT** have a built-in wireless charging receiver.

Mobile devices with a built-in wireless receiver, compliant with the Qi standard, can be placed directly on the charging spot.

The **KWC-MUSB** Receiver for Micro-USB Connector (see <u>Figure 1</u>) and **KWC-LTN** Receiver for Lightning Connector (see <u>Figure 2</u>) are wireless power receivers that utilize electromagnetic induction to charge mobile devices wirelessly and are compatible with the Qi standard for wireless chargers.

Using the Wireless Charger

To use the Kramer receivers:

- Connect your mobile device to either the KWC-MUSB Receiver for Micro-USB Connector or the KWC-LTN Receiver for Lightning Connector, as required.
- 2. Place the mobile device with the attached receiver centered on the charging spot (correct side facing the charging spot, see Figure 3) until it's fully charged.



You can only charge one mobile device via the charging spot at a time.

When charging a mobile device, do not place any metal or magnetic objects over the receiver.

Charging a mobile device using the receiver in the vicinity of pacemakers, hearing aids, or similar medical electronic devices may interfere with the function of these devices.

Make sure the receivers are used in a cool and well-ventilated environment and away from flammable and explosive objects.

Avoid using the receivers in extreme temperatures or high humidity.
