

Step 1: Check what's in the box








Step 2: Install the VA-102P512

Mount the machine in a rack (using the RK-1 rack adapter) or place on a flat surface.

Step 3: Connect the power outputs

Always switch off the power on each device before connecting it to your VA-102P512.



Step 4: Connect the device power

Connect the power cord to the **VA-102P512** and plug it into the mains electricity.



Step 5: Operate the VA-102P512

Switch on the power.

2.1 Achieving the Best Performance

To achieve the best performance:

- Use only good quality connection cables (we recommend Kramer highperformance, high-resolution cables) to avoid interference, deterioration in signal quality due to poor matching, and elevated noise levels (often associated with low quality cables)
- Do not secure the cables in tight bundles or roll the slack into tight coils
- Avoid interference from neighboring electrical appliances that may adversely influence signal quality
- Position your Kramer VA-102P512 away from moisture, excessive sunlight and dust

3 Overview

The **VA-102P512** is a 10-output power supply used for powering 5V DC and 12V DC powered devices. The **VA-102P512** can supply 5V DC to five devices (at 1.8A max./device for a total of 9A) and 12V DC to five devices (at 1A max./device for a total of 5A).

The power supply is especially useful in high-population installations for saving space and eliminating a large number of stand-alone power adapters.

3.1 Defining the VA-102P512 Power Supply

This section defines the VA-102P512.




Figure 1: VA-102P512 Power Supply

#	Feature	Function
1	Power LED	Illuminates when the power is turned on
2	5V DC Output Connectors	Supplies 5V DC to up to 5 devices
3	12V DC Output Connectors	Supplies 12V DC to up to 5 devices
4	Power Connector, Fuse and Switch	Connects to the mains supply and switches the device on and off

4 Connecting the VA-102P512



Always switch off the power to each device before connecting it to your **VA-102P512**. After connecting your **VA-102P512**, connect its power and then switch on the power to each device.




Figure 2: Connecting the VA-102P512 Power Supply

To connect the VA-102P512 as illustrated in the example in Figure 2:

- Connect the 5V DC outputs to up to five 5V DC devices and the 12V DC outputs to up to five 12V DC devices.
- Connect the AC power cord to the AC receptacle and turn ON the power to the VA-102P512.
